

#### NOTE ON THE PROCESS OF DUE DILIGENCE OF GREENHITECH VENTURES LIMITED

We have been appointed as the Lead Manager for the proposed Initial Public Issue of **Greenhitech Ventures Limited** ("GVL" **OR THE "COMPANY" OR THE "ISSUER"**). As mandated under the SEBI (ICDR) Regulations, 2018, we herewith submit a brief note on the diligence process adopted by us:

#### Current business background, about the Operational Structure and the Business Strategy:

Two Executives of Beeline Capital Advisors Private Limited (Lead Manager to the Issue) had visited the registered office of the Issuer Company situated at B27/92 K1 Jawahar Nagar Colony, Bhelupura Varanasi-221010, Uttar Pradesh, India.

- 1. They have inspected the Office Infrastructure, Staffing systems and Procedures etc w.r.t. the Company's business. They also have examined various documents including those relating to litigations, approvals, Disputes with statutory authorities etc. and other Material documents in connection with the finalization of the Prospectus pertaining to the said issue.
- 2. They had discussions with the Board of Directors, Promoters, KMP's including the support staff regarding the business operations and related activities of the Company and gone through other documents / websites in order to further understand the actual procedures of business.
